Dear Parent:

We will be hosting an online session as part of our programming that requires your permission prior to participation. We have provided you the details of the online program and request that you complete and sign the permission form. Please note that all online activities have risks. The safety of your Child is our primary concern. Precautions will be taken for their protection.

All online engagement programming will be hosted through Bethel's licensed account, regularly monitored by Bethel Leadership. Attendance will be taken at the beginning of all online programs. All sessions will be recorded for security purposes and maintained on a confidential drive permanently. Parents are provided with an opt-in clause below, in which parents may choose to consent to their child using webcam during the recorded session. For parents that do not opt-in, their child will not be permitted to use webcam during the session but will be able to participate in the programming with Zoom audio and chat box.

We have taken precautions in providing this programming. However, we feel we have the responsibility to share with you the risks associated with any online activity.

These risks include but are not limited to: risk of your child switching screens or your child disclosing personal information.

We ask that you be present in the room with your child(ren) at all times during the Zoom video group.
